

GENERAL TERMS AND CONDITIONS OF THE TENDERS FOR SALE OF PASTEURIZED COW MILK .

TERMS AND CONDITIONS FOR SUBMITTING THE TENDER

1. Reputed Milk supplier/Co-Operative milk Unions/Milk Federations equipped with sophisticated technology with collection & processing and storage facility and sound financial capability for milk purchase can participate in the tender
2. Prescribed tender forms will be available online on the website www.goadairy.com .
3. The Bidder should agree to Purchase Pasteurized Milk from Goa Dairy, confirming to the FSSAI Rules for the limited period of one to two months on ex-dock basis.
4. The eligible bidder should have an annual turnover not less than Rupees 5 **Crore** in the last financial year.
5. Validity period of a tender shall be for a period of 45 days from the date opening tender.
6. The Bidder should transport the purchased milk in well-insulated road milk tanker.
7. The Bidder should agree to Purchase milk not exceeding 0.13% Acidity and temperature should be below 8°C at the time of lifting from the Goa Dairy Plant.

Quantity:-

1. The Bidder should lift the cow milk as per the schedule provided by the Milk Union on available excess milk basis. Approximate requirement of various type of milk is as below and as per the specification .
2. Basic cost of pasteurized cow milk for fat 4.0%/SNF 8.5% have to be quoted & for additional fat per point above 4% will be added @ 0.20 paise per point & additional SNF above 8.5% will ne added @0.10 paise per point.

- 📁👤 The supplier should pay the amount in advance before lifting the milk from Goa Dairy Dock.
- 📄👤 The Cess charges @ 15 paise per litre, & 'Market Fee' @ 1% of the milk value will be added if applicable.
- 📄👤 The bidder should agree that, the weighment (ltr/ kgs) and testing carried out by Goa Dairy quality control lab report will be final and shall be acceptable to the bidder . However with prior permission the supplier can witness the analysis in QC Lab of Goa Dairy for confirmation of the results before dispatching the milk tanker.
- 📄👤 All the disputes arising out of the milk supply will be subject to the jurisdiction of Ponda Court only.
- 📄👤 The successful tenderer has to lift as per the instructions of Goa Milk Union
- 🕒👤 Goa Milk Union reserves the right to reject any or all tenders without assigning any reason.
