#### GENERAL TERMS AND CONDITIONS FOR SUPPLY OF BUFFALO MILK

- 1. Supplier agrees to supply Pasteurized Buffalo Milk to the Dairy, confirming to the FSSAI Rules and also confirm to FT-1 MilkoScan Machine installed at Goa Dairy.
- 2. Refundable EMD of Rs. 5,00,000/- (Rupees five lakhs only) should be enclosed, a Demand Draft of Nationalized Bank/RTGS details along with the tender while submitting the same. Successful bidders EMD will be converted into Security Deposit.
- 3. The supplier agrees to supply milk in the well-insulated road milk tanker also cleaning record book should be maintained on daily basis, before loading and unloading of milk.
- 4. Supplier agrees to supply milk not exceeding 0.14% Acidity and temperature should be below 7°C at the time of receiving in the Goa Dairy Plant.
- 5. The supplier agrees to supply Pasteurized Buffalo milk (FAT 6.0/SNF 9.0) as per the schedule/Purchase order provided by the Milk Union on Weekly / Monthly basis.
- 6. However in case, Milk is accepted by Goa Dairy then penalty clause per point deduction will be double per point below FAT/SNF. For example: For Past. Buffalo Milk incentive of 40 paise per point rise in Fat will be paid for Fat above 6.0% and deduction for Fat below 6.0% will be made twice per point. (e.g. for 5.9% Fat deduction will be 80 paise per point and so on)Incentive of 10 paise per point in SNF will be paid for SNF above 9.0% for Past. Buffalo Milk and deduction of twice per point will be made for SNF below 9.0% (e.g.8.9% SNF 20 paise per point and so on)
- 7. For the Past. Buffalo Milk, MBR test for pasteurized milk should not be less than 5 hours. Temperature of milk should be below 7°C
- 8. The Alcohol test and COB test must be negative. Phosphatase Test should be negative.

- 9. The supplier agrees to raise the bill on weekly twice basis.
- 10. The supplier agrees to receive payment by RTGS in favour of supplier.

- 3. The supplier agrees to supply milk in the well-insulated road milk tanker. also cleaning record book should be maintained on daily basis ,before loading and unloading of milk.
- 4. Supplier agrees to supply milk not exceeding 0.144% Acidity and temperature should be below 7°C at the time of receiving in the Goa Dairy Plant.
- 5. The supplier agrees to supply Pasteurized Cow milk (FAT 4.0/SNF 8.5) as per the schedule /Purchase order provided by the Milk Union on Weekly / Monthly basis.
