TWO ENVELOPE METHOD

The tender shall be submitted in the two envelopes method. One of which will be called “Envelope of Technical Offer” and other one a “Commercial Envelope” or “Envelope of Rates”.

1. **The envelope of Technical offer** shall contain the following documents:
 - (a) **Cash receipt / Demand Draft / NEFT / RTGS details of Rs.1000/-** as a Tender Form fees.
 - (b) **EMD amount Rs. 60,000/- as per statement below** By way of **Cash receipt or Demand Draft / Nationalised Bank Guarantee** having minimum 6 month validity on the value quoted against each item in the Commercial envelop or Envelope of Rates. DD in favour of Managing Director, **Goa State Co-operative Milk Producers' Union Limited**, payable at Ponda Goa. **NEFT / RTGS details if amount is transferred online. Copy of MSME Certificate if opted for exemption.**

16. Mode of payment towards cost of the Tender Document, EMD.
17. Suppliers has to provide MOU with concern manufacturer from which he would supply Cattle Feed. Also he should produce above documents (from 2 to 17) from concerned manufacturer.

INSTRUCTION TO MANUFACTURER OF CATTLE FEED

1. The intending bidder must quote the lowest bid & tender for period of 12 months.
2. The intending bidder must read terms & conditions carefully, he should only submit his bid if he considers himself eligible and is in possession of all the documents required.
3. The information and instruction for bidders posted on GMU website shall form part of bid documents.
4. The bid documents consisting of quality (specification), quantity of Cattle Feed is uploaded on the official web site.
5. The bidders shall quote the lowest bid, including GST, @ 18%, entry tax, cess etc if any on the quantity supplied.
6. It is the responsibility of the bidder to ensure the credit of Tender Document fees and EMD into the respective receiving bank accounts of GMU via various modes of payment mentioned above, on or before last date and time of tender.
7. Successful bidder has to undergo / enter into contract with GMU.

Tender without providing above required documents/information is liable to be rejected forthwith.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved with the Managing Director issuing the tender.

The Managing Director of The Goa State Co-operative Milk Producer's Union Limited, Curti Ponda Goa reserves the right to accept or reject any tender or all the tenders without assigning any reason thereof and his decision in this regard shall be final. For any legal dispute the jurisdiction will be at Goa only.

**GENERAL TERMS AND CONDITIONS OF THE TENDERS FOR
PURCHASE OF CATTLE FEED THROUGH OPEN TENDER .**

1. A Tenderer must purchase his tender form in person, from the Accounts Section of Goa State Co-op.Milk Producers Union Limited, Curti Ponda Goa or download form from our website www.goadairy.com and to be submitted along with the tender fees of Rs. 1000/- (Rupees One Thousand Only) in the form of Cash receipt/DD in envelope of Technical offer. Tenders without tender fees will be summarily rejected.
2. Bidder should quote rates for F.O.R destination Cattle Feed Plant, Marvasada – Usgao including all taxes & other costs.
3. E.M.D **amount @ 60,000/-** on the value quoted against the total amount of Cattle Feed By way of RTGS/NEFT shall be credited by the tenderer which will be converted as performance security till the supply of cattle feed of successful bidder. If the bidder is applicable for EMD exemption attach necessary documents for the same.(attach MSME registration certificate /National Small Industries Corporation registration certificate)
4. Validity period of a tender shall be for a period of 45 days from the date opening tender.
5. Successful bidder should attach the certificate of Analysis of cattle feed along with the consignment.
6. Bills: Bills should be prepared in the name of Managing Director Goa State Co-operative Milk Producers' Union Limited, Curti Ponda Goa in duplicate mentioning the basic cost of the cattle feed & other components including taxes separately.
7. Loading & Unloading charges should be paid by Manufacturer/supplier.
8. The complaint in respect of misquoting or typographical error etc. Will not be entertained, after opening of the tender.
9. The bidder must quote the lowest rate in figures for the unit given in the tender form only.
10. The bidder who is qualified for technical bid shall be considered for the financial bid.
11. The rates should be quoted for free delivery at the cattle feed plant Marvasada – Usgao Goa of Goa Milk Union.
12. The quality of the cattle feed should be as per the specification attached at Annexure C, which should be strictly adhered upto / till the end of the contract. No payment will be made, if the quality is not maintained.
13. The successful bidder has to deposit Rs. 8,00,000/- (Rupees Eight Lakh Only) as performance guarantee within 7 days from the issue of order and same will be refunded on successful completion of contract, in case for any undue situation the contract is cancelled/terminated, then EMD will be forfeited.
14. The bid without proper documentation will not be considered.
15. The bid offered by L1 (lowest one), will be final only when the sample of the cattle feed is tested at laboratory of GMU and the feedback of the farmers will be considered, for finalization of the contract.
16. **EMD:**
 - The Earnest Money Deposit of the successful bidder will be adjusted against the security deposit till the end of the contract and no interest will be paid for the said period. In case he has attached MSME for exemption of EMD, then successful bidder has to deposit the same.
 - The Earnest Money Deposit of the unsuccessful bidder will be refunded within 30 days from the opening of the tender.

- The Earnest Money Deposit will be forfeited, if the performance guarantee is not submitted.

17. QUANTITY:

The quantity as specified in Annexure 'E' which may be increased / decreased, as per need of the Goa Milk Union.

18. QUALITY:

The quality of finished goods (cattle Feed) will be as per the specification (Annexure 'C') which determine further course of action.

The supplier expressly warrants that, the finished goods supplied to the GMU will confirm the specification/ descriptions/designs.

The material must be free from adulterants, Chemicals, insects, fungus infestation, aflatoxin, fermented, musty, rancid, castor seed / husks and objectionable odours. Further it must also be free from extraneous matter including Iron and other metallic pieces.

Raw Material used for manufacturing of Cattle Feed should be as per Annexur

19. REJECTED GOODS:

If any finished goods (cattle feed) are rejected, the buyer (GMU) will inform the supplier in writing/email about the rejection.

The supplier on receipt of communication in writing/email from the buyer (GMU), the rejected goods will be replaced within 8 days from the date of issue of letter/email, at his own expense.

If the supplier failed to lift the rejected goods, the the GMU will dispose the goods at the risk and responsibility of the supplier and the payment of bill will be revised accordingly.

If the supplier fails to fulfill the above conditions, then in lieu of violation of the terms and condition, the option is open to the GMU to terminate the contract.

20. SAMPLE TEST:

The finished goods (cattle Feed) supplied by the supplier will be tested at laboratory of the GMU and will be determined the order of the finished goods.

If the bidder is not satisfied with the results of sample tested at laboratory of GMU, the supplier may in writing request the GMU for test of sample to third party.

The cost of sample test through third party will fully borne by the supplier.

21. WEIGHTMENT:-

Every delivery of finished goods supplied will be measured (in weight) by GMU at the cattle feed plant, Marvasoda, Usgao Goa.

Final billing will be considered as per weightment done at Cattle Feed Plant weighbridge.

22. DELIVERIES:

Unless it is expressly agreed by GMU in writing (ORDER), the need of finished goods by GMU, no supply will be made by the supplier.

As per the demand of the DCS (societies) under the control of GMU, the order will be placed at the given address and time (between 10.00 AM to 4.00 PM).

During the trial feed, the expert team of the supplier will work in coordination with the procurement team of the GMU to supervise the feed consumption by animals (cow/buffalo) during the period.

23. PACKING :

Packing should be 50 kg PP Bags (High Energy, High Protein & Pregnancy Ration) of LxB 39"x28" & wt. 120 gm.

For Calf Ration & Maize Chunni packing should be 25 kg laminated PP bags (32"x24" & wt 110 gm)

No charges for packing/forwarding or coolie & cartage shall be payable by the buyer under orders placed against this tender unless otherwise expressly agreed to in writing at the time of placing the order. However, damage to any goods not packed to ensure complete protection will be charged to the seller.

The seller shall use sound PP bags for packing as per specifications & printed format provided by buyer within his scope. Any changes in printing matter in future will be borne by seller.

The Unloading charges @ Rs. 120/- per MT to be paid strictly at the time of delivery of Cattle Feed by the supplier.

Every bags should have / inserted the slip mentioning the date of manufacturing & batch no.

24. TERMS OF PAYMENT:

Payment shall be made based on quantity of feed received at our plant net off the average weight of empty PP bags.

The payment of cattle feed will be made within 25 days after receipt of the goods.

The supplier should forward the invoice/bill copy in original, no xerox copy will be entertained.

The payment of rejected cattle feed will be revised.

The supplier shall submit the bill inclusive of GST at appropriate rate.

25. ACCEPTANCE AND CONFIRMATION:

The purchase order will be placed to supplier via e-mail and reply of the same is not received within 3 working days, then the order issued is treated as acceptance of the supplier.

26. CANCELLATION OF PO:-

The GMU reserves the right to cancel the whole or part of purchase order by giving 3 days notice in writing /email/ telephonic.
