**INSTRUCTIONS FOR SUBMISSION OF TENDER FORM & DOCUMENTS**

1. The bidders who are interested may collect the tender form along with terms & Conditions of the contract by paying Tender Fee (non- refundable) of Rs. 1000/- ( Rupees One thousand Only) per Tender document from the office of the Milk Union during office hours .
2. The tender shall be submitted in the two envelopes method. One of which will be called “Envelope of Technical Bid” and other one a “Envelope of Financial Bid”.

**A. The envelope of Technical Bid shall contain the following documents:**

- Cash receipt or Demand Draft of Rs.1000/- as a Tender form fees.
- EMD amount Rs. 10,000/- By way of Cash receipt or Demand Draft of Nationalized Bank, having minimum 6 month validity DD in favour of “ Goa State Co-operative Milk Producers’ Union Limited, payable at Ponda Goa.
- General Profile of Tenderer. --- Annexure – III
- Pan Card Copy
- RC Book of Vehicle
- Insurance Certificate
- Fitness Certificate
- Pollution Certificate
- Scope of work & General Terms & Conditions as per Annexure II

**NOTE:** All certificates as per documents mentioned in the above should be invariably signed by the bidder. Above documents must be submitted in the “Technical Bid envelope” failing which “Financial Bid Envelope” of such tenderer’s will not be opened.

**These envelopes shall be kept together in a big envelope, which shall also be sealed.**

3. Tenderers having any case/dispute against them Goa milk Union have right to reject.
4. Tenderers who are presently or in past under contract with Goa Milk Union or any other milk union and have been caught/punished in any theft case shall not be able to participate in this tender.
5. Tenderers who have been blacklisted/ termination of agreement in past by Goa Milk Union shall not be considered for this tender.
6. Tenderers having any financial dealing with any of the employees of milk union as on date of submission of tender shall not be considered.
7. When the union informs the contractor of acceptance of his tender the contractor will

have to inform the union within 48 hours of his acceptance of the contract and sign an agreement with the union. If the contractor fails to do so his Earnest Money Deposit will be forfeited by the Union and will have the right to assign the contract to any other party.

8. The contractor will have to produce sufficient proof to prove that the vehicle mentioned by him in the Tender form is owned by him at the time of signing the contract. If the entry/entries made in the tender forms were found to be wrong at any time during the contract period the Union has right to terminate contract and the security deposit of the Contractor will be forfeited.
9. If the contractor wishes to fill the tender on the name of the company he will have to produce registration deed of the partners of the company while filling in the tender and only that person can sign for company on the agreement of the contract who has right to sign letters, cheques, documents, etc. of the company. If the tender is filled in the name of a person, his signature will be valid and will have to come to office when Union wants him for work and if there is any change in partners of the company during the contract period then it should be intimated within a week to the Union.

**ANNEXURE - II**

**Scope of work & General Terms & Conditions of Contract**

1. This contract will remain in force from ..... to ..... and the union reserves the right to terminate the contract at any time without giving notice during the period, if the Union is not satisfied with the work of the contractor. However Union may extend the period of contract for additional 3 months or more from the date of completion of contract.
2. The Contractor will have to collect the milk of societies twice Daily (Morning & Evening) and transport the same to Union's Dairy Plant/Chilling Centre/DCS. Contractor will have to deliver Empty milk cans as per the Timings schedule given by the union. The union will determine timings for collecting milk from societies on any particular route and will have right to change timings as and when necessary. The vehicle should reach the first Society in the list of collection centre at least fifteen minutes earlier than the Departure time from that village and will strictly follow the time schedule given by the Union authorities. The contractor will deliver the empty cans and any other materials sent from the union to the authorized person of society/farm and receive the milk and any other material from the society /farm to be delivered to the Union.
3. It is the responsibility of the contractor to get the proper entries made on the truck sheets duly signed by the authorized person of the society/farm and deliver the Truck sheets back to the authorized person of the Union as proof of handing Over and taking over the milk cans, milk and other material. In case the truck sheets are not delivered to Union's office and also if there are no proper entries taken in the required columns of truck sheets any shortage or losses claimed by the societies on route on the particular date will be recovered from the Contractor.
4. If the contractor does not send his vehicle to the Union's office for the purpose on the day mentioned in the schedule provided to him/her, then an amount of Rs.1000/- will be deducted from his bill and further any expenses incurred for arranging the alternate Vehicle by Union on the said day/subsequent day will be recovered from the Contractor or adjusted from contractor bill. Similarly if milk is spoil due to not sending of vehicle by the contractor for a specific days, then cost of spoilage of milk will also be recovered from the contractor or adjusted from his bill.
5. It will be the duty of the contractor to inform the Union immediately if he/she has failed to bring the milk from any particular society of the Union giving the reasons.
6. It will be the responsibility of the contractor to keep a proper record of Commodities to be transported in the vehicle. This record will have to be kept as per the instructions of the Union. The contractor will be responsible for any damage or loss caused to the materials while transporting to the union or to the Societies.

7. For any reasons when the Union decides to discontinue milk collection from any society/farm on the route the contractor will not ply his vehicle to the route of such societies/farms and during this period the Union will not have to pay any charges or compensation to the contractor.
8. It will be the responsibility of the contractor to send a substitute vehicle of same make incase his vehicle fails while transporting milk, and to bring to the notice of Union immediately about such arrangements in writing.
9. While bringing the milk if vehicle goes out of order and milk is transported by vehicle of other route it will be the duty of the contractor to inform in writing to the Union about the additional milk brought by him/her. If the aforesaid contractor has not fulfilled the conditions Union will deduct 25% amount from the day's bill of both the routes. If this arrangement is made not more than once in a month the Union may not deduct 25% amount from one day's bill.
10. The contractor will be responsible for milk sourage/curdled on late arrival of his vehicle at the reception dock of the Union' s Dairy Plant. The loss will be recovered from his transport bill. During the collection milk vehicle should not be stopped at any other places unnecessarily except at the collection centres.
11. In case the Milk Union decides to install cooling system for the vehicle it will be binding on the contractor to accept the same.
12. The Union will have right to send its representative{s} with the vehicle of the contractor whenever it is necessary and the contractor should provide a seat{s} in his vehicle for person/s.
13. The contractor will not carry unauthorized persons/passengers or any other material without the prior permission of the Union, while transporting the commodities of the Union. Every vehicle which carries those commodities should stop at the main gate of the Dairy Plant and the vehicle should proceed to the Dairy dock and outside only after receiving a token and gate pass, from the watchman, respectively. The truck sheet of the milk vehicle will not be accepted without the token at the dock. The speed limit of the vehicle should not be more than 15 km/hr in the compound of the Union.
14. In addition to milk cans etc. the contractor will have to transport any other materials as and when asked by the Union.
15. Any instructions made in writing on the truck sheet by any authorized person of the Union for delivering any item to the society will be considered as the written notice to the contractor and it will be binding on his part to carry out the instructions within 48 hours failing which the Union will make alternate arrangement to transport the materials and the expenditure incurred by the Union will be recovered from the bills of the contractor.

16. Contractor will have to follow the instructions of the Managing Director or the officers authorized by him to fulfil the terms and conditions of the contract, if contractor fails to act or found to be negligent, the Union will take suitable action and assess the damages caused to the Union. The proportionate amount towards the damages caused will be recovered from the bills of the contractors.
17. According to the instructions issued by the union from time to time the contractor is required to carry processed milk packed in polyethylene sachets or packets of butter, ghee, cream etc. to the societies or any parties on route on regular or casual basis. In such cases he should take delivery of the materials mentioned above packed in intact condition and deliver the same to the societies/parties not causing any damages, loss or shortages in weight. If any loss incurred during the transportation the same will be recovered from the contractor's bill. It is the responsibility of the contractor to get the delivery challans duly signed by the authorized persons of the society/party and return the challan to the Union.
18. After the acceptance of tender if the contractor fails to act according to the terms and conditions of contract any losses incurred by the union or societies will be recovered from his bills. In case after the acceptance of the tender if the contract conditions are not implemented accordingly or if there is any breach of condition of the contract the union has every right to cancel or to get the work done by the alternative arrangements . In doing so whatever additional expenditure/losses incurred by the Union will be recovered from the contractor.
19. On acceptance of the tender the contractor will have to deposit Rs.50,000/- (Rupees Fifty Thousand Only) & for Shuttle route Rs. 25,000/- (Rupees Twenty Five Thousand Only) as security deposit with the Union. For the refund of this deposit contractor has to apply in writing within one month after the contract is completed. This deposit will be refunded after deducting the amount to be recovered by the Union and societies if due latest at the end of 3 months after the period of contract is completed. This settlement will be made on obtaining receipt from the contractor. It will be the liability of the contractor to furnish no due certificate from the societies of his route. The contractor will forfeit the permanent deposit if he fails to carry out the contract for full terms of the contract. Here all the correspondence submitted by Contractor shall be certified and forwarded to Managing Director by the concerned Sectional Head/Incharge of the Union to whose Section vehicle is allotted for required routes for making necessary payment in Account Section of the Union.
20. The age of the Vehicle Driver should not be more than 60 years and he should be Physically/Medically fit to drive the said vehicle.
21. It is the responsibility of the Contractor to keep the Vehicle clean and in good condition at his costs. Floor of the Vehicle shall remain clean and there shall not be any hole/break/gap on the floor of the vehicle.

22. It is the responsibility of the Contractor to load/unload the Can/Crates/other Material of the Union as and when required as per the direction of the Official of the Union. Further the Contractor/Driver of the Vehicle is required to carry parcel of the Union to be delivered at concerned DCS/Milk Distribution Point/Selling Point/ other place as per the direction of the official of the Union as and when required.
23. The contractor shall display the necessary Hoarding/Board of the Union for advertisement as and when required by Union and at the front of the Vehicle the Contractor shall display specific Board stating "VEHICLE FOR GOA DAIRY ON CONTRACT".
24. The Driver of the vehicle will have to undergo checking with Alco meter at the Security Gate and if found under the influence of alcohol liquor then penalty of Rs.2000/- would be imposed on each occasion to be recovered from Contractor's bill and further if the said Driver is found in such condition for three times then the contract would be terminated by Union.
25. If the union desires to install GPRS system in the Vehicle for monitoring of KMS. Then the same will be installed by the Union and for which Contractor will have to deposit Rs.1000/- as Security Deposit which will be refundable to the Contractor after the completion of the present contract. Further the Contractor will have to abide with the terms and conditions of the GPRS system.
26. Speedometer of the Vehicle should be in working condition and it should record the distance precisely. The officer on the vehicle will certify the kilometres and the amount will be paid accordingly. If the speedometer is not working then the kilometre fixed by the Union for the route on that day will be considered for calculation or charges to be paid and the same should be acceptable to the contractor.
27. The concerned Sectional Head of the Union has to submit the performance Report of the Contractor pertaining to the present contract once in six months with the Managing Director of Union.
28. The vehicle put by the contractor for milk collection route should be in sound mechanical conditions and should have a metal or tarpaulin hood over the carrier portion to protect the milk from the sun, rain etc. The vehicle should have a valid fitness certificate and attested Xerox copies of which should be furnished at the time of signing contract.
29. The contractor will not engage a vehicle belonging to any other person for this transport work without permission of Union and will not hold any position in the union.
30. Upon the death of the Contractor the legal heir will be entitled to all the rights of the contractor i.e the contractor can be directly transferred to the legal heir by the Union with the consent of Managing Director.

31. The Union has the authority to allot additional societies, reduce the number of societies and to make necessary alteration in particular milk route. The contractor will have to inform the Union at the earliest about changes occurred in distance due to these alterations. The union will pay the contractor for the additional kms. Or deduct from the total amount for the reduction in kms. As per the original schedule. In case of reduction in distance the amount will not be deducted more than 10% of the original amount of the contract. If the increase or decrease is more than 10% the union will be entitled to invite new tenders, cancelling the contract.
32. After the contract is signed, the contractor has to use his own vehicle in the route. He will not have the right to give sub contract to any person. However the Union reserves the right to transfer the contract to any person in special circumstances on the request by the original contractor. A transfer fee of Rs.500/- Will be charged to the original contractor if the transfer is made before the effect of the contract and Rs. 1000/- will be charged after the effect of the contract. Written consent of the party getting the contract transfer is necessary. However the approval of the Board will be required.
33. During the monsoon or such circumstance when roads are wet and when the contractor's vehicle cannot go right upto the society when milk is to be collected the contractor will have to take his vehicle as nearer to the society as possible. And it will be duty of the contractor to make necessary arrangements to lift the milk cans from the societies collection centre either by labourers or any other means and deliver it to the dairy dock in time. If the contractor inform the society in writing and also sent a copy of that letter to the Union it will be the responsibility of the society to send their milk from the centre of the society up to the vehicle. For this the contractor will have to

bear the head load charges to the societies not more than following rates.

For 40 kgs a distance upto half km.....Rs. 3.00

For 40 kgs a distance upto 1 km.....Rs. 5.00

For 40 kgs a distance from 1 km upto 8 km..... contractor has to pay Rs.0.50 for every additional 0.1 km as labour charges (i.e for 1.6 km the contractor has to pay Rs.5.00+Rs.3.00 extra charges  $0.50 \times 0.6 \text{ kms} = \text{Rs.}3.00 = \text{total Rs.}8.00$  for 40 kgs of Milk)

**Note:** the amount will be fixed on the quantity of milk delivered to the Union.

1. If the head load charges exceeds the aforesaid charges the society will be bear the additional head load expenditure for a distance of more than 8 kms. The contractor will have to take prior permission of the Union.
2. The contractor will have to agree to any condition which the Union may lad down for such permission of the transport on the head load and the rate fixed by the Union will be final.
3. At the time of dispute between the society and the contractor regarding the distance of head load the decision given by the Union and the distance measured by the Union for the head load will be considered final.

34. The contractor will have to submit the half monthly bills for the transport for every fortnight on or before the 3<sup>rd</sup> and 18<sup>th</sup> day of every month which would be then certified by the concerned Sectional Head and recommended for payment to the Account Section of the Union. After the sanction of this bill the union will make the payment for the bill on the 10<sup>th</sup> and 25<sup>th</sup> of the month to the contractor on A/C Payee. The contractor will have to pay the amount to be paid the societies by A/C payee cheques. If the contractor has not paid his dues to the societies for the head load charges in the subsequent month and if the contractor has not taken Union's approval for doing so, the head load charges payable to the societies will be deducted from the contractor's bill and will be paid to the societies concerned. If the contractor has not received the bill for the head load he should get the weight of the milk form the Union and should send charges to the societies for the head load and should deposit the amount in the Union's office.
35. As stated in the condition No.23 contractor should fix the rate of labour charges place for sending head loads and distance in consultation with society and inform about that to the Union before the beginning of monsoon, the contractor will have to pay the head load charges to societies in the subsequent month and will have to give a copy of the receipt and other information to the Union. If this is not done the union will deduct that amount from the contractor's bill and will pay it to the society. It will be the right of the Union to deduct remaining dues of the contractor from his last month's bill.
36. If the person employed in the contractor's vehicle misbehave towards the Union's or societies staff the Union will have right to forbid such person from entering the compound of the Union/Dairy plant or to ask for removing him from services of milk route vehicle.
37. Before completion of the period of contract the union has the right to extend the contract work for a period of 3 months or less beyond the date of completion of the contract on the same terms and conditions as agreed in the contract.
38. For convenience of work the iron sheet fixed on the vehicle should be such that they should not harm the persons working on the vehicle. After getting the instructions for repairing it should be repaired within seven days and should inform the Union about that in writing and if it is not done and any damage is caused then the loss in this regards will be recovered from the Contractor.
39. Contractor will be paid for 2,500 kgs for pay load capacity of 2.5 ton and 3500 kgs for pay load capacity of 3.5 ton or equivalent vehicle of milk per collection time according to the contract rate for the milk brough from the societies to the Union but for additional milk he will be paid additional charges 10 Rs. Per 100 kg of Milk.
40. For driving the vehicle above prescribed speed limit in the Dairy, for not parking the vehicle at its prescribed place, for bringing an authorized person with the vehicle for cleaning the vehicle in the compound of the dairy and for not complying the condition of contract and for every such occasion Union will have a right to charge damages and/or service charges of Rs.500/-.

41. The contractor should work himself to fulfil the aforesaid conditions of the contract. If he employs any person to fulfil the conditions he will only responsible for all those persons including labour acts and rules binding upon them.
42. The contractor will be responsible for loading and unloading of milk and empty milk cans at societies and other milk collection centres and at Dairy Dock.
43. The vehicle put by the contractor for milk transportation should be in sound mechanical condition and should have metal/tarpaulin hood over the carrier portion to protect the milk and other commodities belonging to Union and societies form sun, rain, etc. The vehicle should have a valid fitness certificate and attested copy of which should be furnished at the time of signing the agreement . The union will pay only 90% of the charges for the days when this condition is not fulfilled and no reimbursement refund will be allowed in such case.
44. Union has right to terminate the contract of the contractor if he plies for the contract any other vehicle other than the one mentioned in the contract without prior permission of the Union. If the contract is thus terminated the security deposit of the contractor will be forfeited.
45. In case of any inquiry by the authority under the aforesaid Employees State insurance Act, 1948, Employees Provident Funds and Miscellaneous Provisions Act,1952, the Contractor further undertakes to produce the Wages Register, attendance register and other relevant records before the Authorities or the Inspector under the said Act as and when demanded by them.
46. Every contractor has to pay non-refundable amount of Rs.100/- to enroll him as a nominal member of the Union for the period of contract within one week of executing the contract.
47. Whatever the taxes/toll charges applicable for plying the vehicle on crossing of road/bridges and rivers are to be borne by the contractor.
48. In case of any dispute between the contractor and the Managing Director and if the contractor demand the dispute will referred to the higher authority of the Union and the decision given by the higher authority of the union will be final and biding to both the parties.

49. Only the driver of the vehicle and a person kept on the vehicle for loading/unloading of cans will be allowed inside the Dairy compound and such person have to leave the Dairy compound along with vehicle. It will be the responsibility of the contractor to ensure that the persons employed by him are not inside the Dairy premises more than the time required for delivering the milk carried by the vehicle. The contractor agrees and undertake to comply with and confirm to all the statutory and other regulations concerning the employment and engagement of labour the rights duties and his obligation as employer to labour and all matters concerning labour and to hold the Company indemnified accordingly. In particular the contractor shall comply with the provisions of the contract Labour {Regulation & abolition} act, 1970 and rules there under payment of wages Act, 1936 and the Rules there under minimum wages 1948 and rules there under etc. And such other laws as may be applicable to him. The contractor further agrees and undertake to pay to the driver and Helper, if any engaged on the vehicle the minimum rates of wages as applicable to the Motor Transport Workers Act, 1961 and as fixed by the state Government from time to time under the Scheduled Employment namely 'EMPLOYMENT IN PUBLIC & PRIVATE MOTOR TRANSPORT UNDERTAKING' and shall indemnify and keep indemnified the Union. The contractor further agrees and undertake to indemnify the Union against all claims by way of compensation or otherwise which may be made against the Union under the workmen's compensation Act, 1923 or any other statutory modification thereof or under any other law for on in respect of any accident, injury or death to Driver and helper, if any engaged by him in the execution of the work under this Agreement.
