## TECHNICAL SPECIFICATIONS FOR UNSALTED YELLOW COW BUTTER

Unsalted Yellow Butter (Cow) conforming to IS 13690 (Part-I), 1992 and satisfying the requirements of FSSAI Rules. The 20/25 Kg butter blocks shall be strapped in food-grade, transparent, unprinted, polythene wrapper/film of minimum 50 micron thickness. Butter paper shall not be used. Outer packing shall be of at least 5-ply cardboard cartons properly gummed/cello taped. The butter shall not be more than Six months old. The Butter shall be made from fresh Cow Milk and it shall be free from any adulterants.
