ANNEXURE-III

GENERAL TERMS AND CONDITIONS

1. This contract will remain in force for as and where basis from the date of issue of order to the tenderer.
2. Contractor has to deposit Security amount for Rs. 30000/-(Rs. Thirty thousand only) for scrap gunny bags.
3. Contractor has to pay applicable Govt. Taxes (GST) & other taxes as per rules and regulations.
4. Contractor has to provide GST & PAN No.
5. Contractor has to lift the material within 7days as & when informed by the management.
6. Contractor has to lift the material on as is where is basis.
7. Contractor has to deposit the value of Scrap Gunny Bags to be lifted in advance to the accounts department of the Office. The bill issued by the accounts department should be produce at Cattle Feed Plant before lifting of scrap gunny bags.
8. Contractor has to lift all scrap gunny bags material regularly.
9. If contractor does not lift the material in time, contract will be cancelled & we may forfeit the security deposit.
10. The vehicle for the scrap gunny bags lifting & carrying will be arranged by contractor at their cost, the contractor has to make arrangement for loading of same.
11. Scrap Gunny bags will be issued in numbers as per tender.
12. While taking delivery of scrap gunny bags, the contractor should take only sold scrap gunny bags, if he is found taking other then sold material, his contract will be cancelled & we may forfeit his security deposit.

13. Contractor should take all the scrap gunny material of contract awarded to him without any objection.

14. Contractor should lift all the scrap gunny bags material till his contract period. Otherwise he will not have any claim after.

15. If at any time, it is found that the lifting of scrap gunny bags has been delayed/stopped the Goa Milk Union reserve the right to sell the said material to any other party at the prevailing market rate. In this case the Security Deposit of the Contractor will be forfeited.

16. Tenders without Earnest Money Deposit will not be accepted.

17. Scrap Gunny bags material will be delivered between 9 AM to 4 PM from Monday to Friday.

18. Conditional tenders will not be accepted.

19. If any dispute or difference shall arise between the parties hereto relating to this contract or the interpretation thereof or in any other matter in any way arising out of or connected with the subject matter thereof, the same shall be referred to the Chairman, Committee of Administrators/Board of the Goa Milk Union. The decision of the Chairman, Committee of Administrators/Board in the matter shall be final and binding on both the parties.
