#### **GENERAL TERMS AND CONDITIONS**

1. This contract will remain in force for as and where basis from the date of issue of order to the tenderer.

2. Contractor has to deposit Security amount for Rs. 30000/-(Rs. Thirty thousand only) for scrap gunny bags.

3. Contractor has to pay applicable Govt. Taxes (GST) & other taxes as per rules and regulations.

4. Contractor has to provide GST & PAN No.

5. Contractor has to lift the material within 7days as & when informed by the management.

6. Contractor has to lift the material on as is where is basis.

7. Contractor has to deposit the value of Scrap Gunny Bags to be lifted in advance to the accounts department of the Office. The bill issued by the accounts department should be produce at Cattle Feed Plant before lifting of scrap gunny bags.

8. Contractor has to lift all scrap gunny bags material regularly.

9. If contractor does not lift the material in time, contract will be cancelled & we may forfeit the security deposit.

10. The vehicle for the scrap gunny bags lifting & carrying will be arranged by contractor at their cost, the contractor has to make arrangement for loading of same.
