1. The diameter of fire wood must not be more than 12 inches not less than 2 inches
2. The length of fire wood must not be more than 3.5 feet.
3. The moisture content of fire wood must be not more than 30%
4. The Calorific value of fire wood must not be below 2250 Kcal/Kg.
5. The fire wood must be free from any moulds and defects.
6. The fire wood supplier must stack the fire wood in our wood godown in proper manner.
7. The Unloading charges must be borne by Supplier.

**ANNEXURE-III**

**GENERAL TERMS AND CONDITIONS**

1. This Bid will remain in force from \_\_\_\_\_ to \_\_\_\_\_ and the Goa Milk Union will have the right to extend the period of contract for additional 3 (Three) months or more from the date of completion of contract.
2. Bidders should quote rates for F.O.R destination excluding GST.If the supplier found to be in defaulted than he will be permanently black listed from the list of supplier of GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD.
3. In the event of the order being placed against any of the tenderer's and if the tenderer fails to supply material, as per terms and conditions **GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD** has Right to place the order to next bidder tenderer. The order of the defaulting supplier will not be considered and difference amount will be deducted from the supplier.
4. The bidder should be registered under office of competent authority or under statutory bodies at the time of bid opening in the same name and style. In order to support this, bidder has to submit :-
5. Copy of the valid Registration Certificate issued by Competent Authority
6. The eligible bidder may be those who have an annual turnover not less than Rupees 10 Lakhs for financial years (2020-21, 2021-22).
7. Liquidated damages: Incase of non -delivery and /delayed /delay in against an order placed with you, **GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD** reserves the right to impose penalty of 1% of Purchase order amount per week beyond the contract period.
8. **Mode of Payment:**
  - Towards Tender document fees (TDF) and Earnest Money Deposit (EMD) to be paid through DD/NEFT/RTGS or Cash.

**Note: Any payment made through NEFT/RTGS will take 24 hours for its reconciliation. Hence the payment through NEFT/RTGS should be made atleast TWO BANKWORKING DAYS in advance before any due date.**

A) An amount Rs 30000/- Earnest Money Deposit shall be credited by the tenderer by the way of RTGS/NEFT.

B) Earnest Money Deposit of unsuccessful Tenderer's shall be refunded within three month.

9. Successful bidders Earnest Money will be converted into security deposit & Security deposit shall be remitted by way of RTGS /NEFT & shall be kept with **GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD** for a period of 15 months on production of original receipt issued at the time of deposit on bank guarantee.

10. Technically qualifying tenderer only will be considered while opening financial bid.

11. Technical Bid will be opened on the date and time as specified & tender qualifying shall be followed by Financial Bid as mentioned in the Tender Notice.

12. Validity period of a tender shall be for a period of 60 days from the date opening tender.

13. GST & other taxes should be clearly mentioned failing which it will be taken as inclusive of all taxes. The tenderer shall also specify the warranty period on the material supplied.

14. Inspection: The inspection of the bidders manufacturing unit will be done by the authorized person of **GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD.**

15. Goods should be dispatched & should be properly covered under transit Insurance However the supplier will be responsible until the entire material arrives in good condition. Goods will be accepted on working days between 9.00 am to 5.30 pm in Goa dairy.

16. **Supply**:-Supply as per schedule given by purchase department of Goa Milk Union after receipt of Purchase Order.

17. **Payment Terms**.

On receipt of material at site, after confirmation of lab & Cattle Feed Plant, Engineering department within 30 days.

18. **Bills**:

Bills should be prepared in the name of Goa State Co-operative Milk Producers' Union Limited, Curti Ponda Goa in quadruplicate. Mentioning the basic cost of other components including taxes separately.

**19. Period of supply :-**

Supply shall be completed on regular basis as per P.O and schedule per month from Purchase order.

20. Unloading of material in Goa dairy plant **GOA STATE CO-OPERATIVE MILK PRODUCERS' UNION LTD** -Curti, charges should be paid by supplier between 9 am to 5:30 pm..

21. Conditional tender are likely to be rejected.

22. Tenderer's should provide the detail technical specification of the item supplied with the tender form.

**23. WEIGHMENT & SAMPLING :**

- Weighment of buyer's factory shall be final.
- Sampling :- The wood will be checked in the Quality control Laboratory for moisture content. If the moisture content is found above 30% the supplied wood should be utilized by deducting the cost of wood by 10%
- Sampling :- If the size of the wood is found above permissible limit then the same will be send back in same vehicle and the weight is deducted from net weight.

**24. DELIVERIES :**

- It is expressly agreed and understood that unless and otherwise specifically agreed to in writing the delivery schedule shall be essence of the contract.
- Without prejudice in any other right of the buyer, buyer reserves the right to refuse or to accept delivery of goods received contrary to instructions as given in this tender or which are not received on or before the specified delivery dates.
- In case the seller fails to deliver the goods within the delivery period specified in the purchase order, the buyer shall have option to either.Cancel the contract for undelivered material.
- To recover from the supplier late delivery penalty charges, not less than half percent of the value of such contract or portion thereof subject to a maximum of 5% if the supplier failed to complete as of aforesaid for each week or part of the week during which the completion of such contract may be in arrears.
- Can ask the second bidder/ L2 to supply the fire wood and the balance amount will be deducted or forfeited from the EMD of the supplier.
- The buyer shall not be liable for failure, to accept delivery of Fire wood under this order, in case such failure is due to causes beyond the control of the buyer including but not limited to acts of god,force majored, fire,floods,accident, lock out strike, slowdown, riot, labour stoppage, or any kind of any act of Govt.



- Deliveries shall be accepted at the factory between 9.00 A.M. to 5.30 P.M. on working days only.

Note: The tenderer's will /shall sign each and every page and attest his seal failing which the tender is likely to be rejected.
