#### **TWO ENVELOP METHOD**

1. This contract will remain in force for one year from the date of allotment of the tender.

2. Contractor has to deposit security amount for Rs 25000/-(Rs.Twenty five thousand only)

*3. Contractor has to pay applicable Govt Taxes (GST) & other taxes as per rules and regulations.* 

4. Contractor has to provide TIN & PAN.

5. Scrap contractor has to lift the material within 7 days as & when informed by the management.

6. Scrap contractor has to lift the material on as is where is basis.

7. Contractor has to deposit the value of scrap to be lifted in advance to the account department of the Office.

8. Scrap contractor has to lift all scrap material regularly.

*9. If contractor does not lift the material in time, contract will be cancelled & we may forfeit the security deposit.* 

10. The vehicle for the scrap lifting & carrying will be arranged by contractor at their cost, the contractor has to make arrangement for loading of scrap.

11. Prior to loading of scrap the vehicle will be weighed at plant weigh bridge & then loaded vehicle will be weighed at plant & then Net scrap weight will be calculated. Net weight of material would be calculated for payment of quantity of scrap based on the quoted price.

12. While taking delivery of scrap, the contractor should take only sold scrap, if he is found taking other then sold material, his contract will be cancelled & we may forfeit his security deposit.

13. Scrap contractor should take all the scrap material of contract awarded to him without any objection.

14. Scrap contractor should lift all the scrap material till his contract period. otherwise he will not have any claim after.

15. Tenders without Earnest Money Deposit(If applicable) will not be accepted.

16. Milk Pouch plastic will be given in poly bags & they have to take it on 'as is where is' basis. (We do not allow to spread for drying in Premises.)

17. Scrap material will be delivered between 9 AM to 4 PM from Monday to Friday.

18. <u>Scrap contractor should dispose off all scrap material as per norms of</u> <u>Pollution Control Board. The contractor has to give under taking for the</u> <u>same.</u>

19. <u>Scrap contractor should have registration in Goa Pollution Control Board</u> <u>for disposal of scrap material.</u>

20. Conditional Tenders will not be accepted.

21. If any dispute or difference arise between the parties hereto relating to this agreement or the interpretation thereof or in any other matter in any way arising out of or connected with the subject matter thereof, the same shall be referred to the Administrator /Chairman of the Goa Milk Union. The decision of the Administrator/Chairman in the matter shall be final and binding on both the parties.
