

#### TWO ENVELOP METHOD

The tender shall be submitted in the two envelopes method. One of which will be called "Envelope of Technical Offer" and other one a "Commercial Envelope" or "Envelope of Rates".

- A) The envelope of Technical offer shall contain the following documents:

    treatment in the Commercial envelop or Envelop of Rates. DD should be in favour of

Tenders without tender fees will be summarily rejected.
- 2. Reputed Pest management professional Bidders should quote rates for providing pest control treatment including all taxes.
- 3. Pest management professional should be current IPCA member.
- **4.** Should enclose the Xerox copy current pest control license.
- 5. Bidder should have executed the value of contract he bided in similar type of industry successfully at least three years(Dairy industry, Food Industry -ISO-22000 certified units). Copy of documents to be attached.
- **6.** Should furnish current clients list in similar type of industry along with conta ct person and contact number so as to get the reference
- 7. Should produce workmen's compensation insurance(In case of accident in companies premises).
- 8. Staff should be adequately trained in-house or by out side agency to carry out safe, effective and appropriate pest management / control measures. (Actual person working) must have proof of experience working In food industry.
- 9. List of pesticides to be used in the premises are acceptable for its use in

- food industry and it can be verified by authority for approval.
- 10. E.M.D amount Rs. 10,000 /- (Rupees Ten Thousand only) By way of DD / CASH RECEIPT /Bank Guarantee of Commercial Bank having validity 60 days shall be submitted by the tenderer which will be converted as performance security till the contract period of successful bidder. If the bidder is applicable for EMD exemption attach necessary documents for the same.(attach MSME registration certificate /National Small Industries Corporation registration certificate)
- 11. Performance Security:-The successful bidder who are exempted from EMD have to submit the performance security amount Rs. 10000/- (Rupees Ten Thousand only) in the form of Account payee Demand draft or Bank Guarantee from commercial bank which is valid for minimum 60 days.
- **12.** Validity period of a tender shall be for a period of 45 days from the date opening of tender.
- **13.** Payment Terms.:- within 30 days on receipt of bill at GMU office and after confirmation of by Production department and Quality control department of Goa Milk Union on monthly basis.
- 14. Bills: Bills should be prepared in the name of Goa State Co-operative Milk Producers' Union Limited, Curti Ponda Goa in duplicate. Mentioning the basic rates of the services & other components including taxes separately.
- **15.** Panalty: If specified work is not undertaken as per requirement, the bidder will have penalty of 20% of the amount of the said service/pest control treatment.

#### **Annexure-C**

#### PEST MANAGEMENT / CONTROL REQUIREMENTS.

Keeping in view the present environmental, hygiene, health and food safety legislation pest management professional should be responsible for the following condition.

- 1. Two pest operator should be deployed on every treatment at Goa Dairy Plant, & Admin Building, at 6.00 pm to 9.00 pm on working days or as per need.
- 2. Also should hand over additional two Cockroach spray bottles as well as Rodent cake packets at the time of every service for emergency use or inside machinery use.
- 3. Contractor (Technical Expert) should be present during major audits to satisfy certifying agencies queries related to pest management and control services.
- 4. Should conduct periodic i.e Bi-monthly thorough inspection of premises, site and present a clear report with details of treatment, recommendations that gives accountability of both sides.
- 5. Should maintain documents and records as per food safety management system standard (ISO :22000:2018 & FSSAI requirements for onsite inspection. Pest Operator will obtain signatures of designated authorities in the section after each treatment as per

- frequency specified in the scope of work and will provide inspection report to concerned about status for accountability.
- 6. Material safety Data sheet of pesticides and standards operating procedures should be provide.
- 7. Only CIB/ FSSAI approved chemicals to be used.
- 8. Shall conduct pest management / pest control care awareness programme to key personals in the company to avoid any likely hazard twice in year.
- 9. Pest treatment should be given to the following premises. Goa Dairy Plant, Ice cream Unit, Admin Building, Basement & Godowns, and all sections like Q.C Lab, Refrigeration & Boiler section, Marketing & Engg. Hall, Area Near ETP, & Plastic waste store Area.

#### DETAILS AS REGARDS TO THE SCOPE OF PEST CONTROL WORK.

#### A) Goa Dairy Plant:

#### 1) HOUSE FLY CONTROL TREATMENT:

- a) Life cycle break down: ETP and all likely breeding areas in and premises where manure and waste food collected.
  - Frequency: Inspection & treatment every fortnightly an as per status.
  - To inform about the breeding locations with reasons to concerned authority for taking preventive measures.
- b) Adult Flies Killing.: Fly resting sites around R.M.R.D, Main Dairy, Production Block, Head Office ETP etc.
  - Frequency: Inspection & treatment every fortnightly an as per status.

#### 2) <u>DESINFESTATION COCKROACH</u>, <u>LIZARDS & ANTS ETC.</u>

Inspection and treatment at such places having pest presence, cockroach hiding, resting places.

Frequency: All manufacturing area .i.e. Milk Pouching, Ice cream unit and all sections in dairy and Admin building, Gutters, Chambers, Drainage lines up to ETP plant.

Every fortnightly and as per status.

3) <u>DESINFESTATION SPIDERS:</u> Inspection and treatment at such places having pest presence, spider hiding, resting places, removal of cobwebs manually after treatment.

Frequency: All manufacturing area .i.e. Milk Pouching, Ice cream unit and all sections in dairy and Admin building,

Four times in year and as per status

#### 4) RODENTS (RATS, MICE AND BANDICOOTS):

- a)Step-1.:- Inspection of entire premise and finding live burrows if any
  - Treatment of burrows by keeping fresh anticoagulant rodenticides.
  - -repeating the treatment by interval of 15 days till finding live burrows.
- b)Step-2. :- In relation to step -1, fixed bait station boxes will be placed in strategic positions and keeping fresh baits.
- changing the bait with interval of 15days.

- -Applying glue boards and mechanical traps as per needs.
- -Suggesting rodent proffing measures, hiding places to remove it.

#### c)Step-3.:- Total No of Baits station 30 +5

- all around the walls of building of Dairy Plant where it is necessary, Godowns, ice cream unit, production section and raw material store.

Frequency:- Fortnightly

d)Step-4:- At cattlefeed plant following areas to be covered:-

- Raw material Godwon No.1
- Raw material Godwon No.2
- Raw material Godwon No.3
- Cattlefeed Godown No.1
- Cattlefeed Godown No.2
- Production Room
- Grinding room
- Maintenance
- Lab, Admim Office, Security Gate, Weighing Bridge
